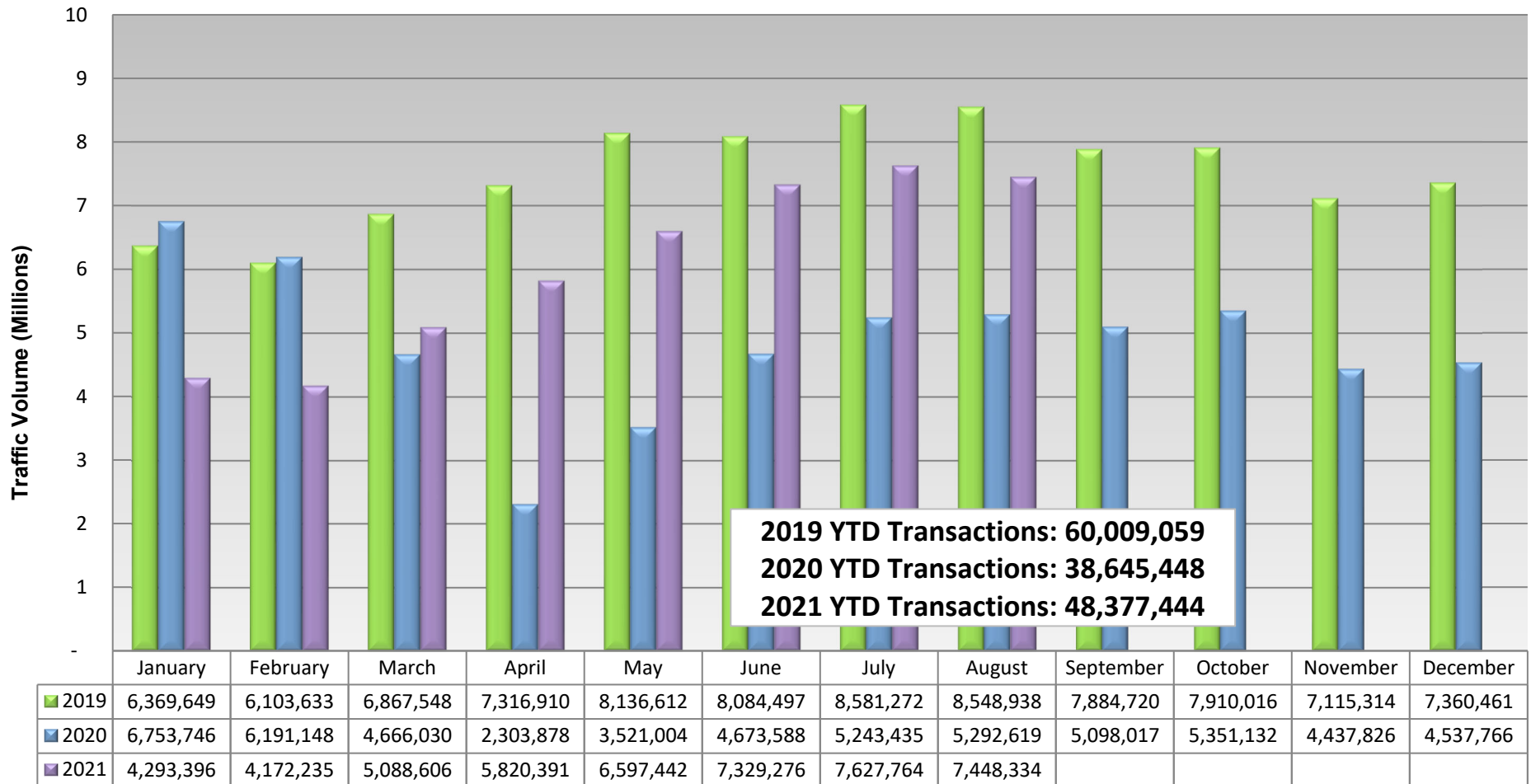




Monthly Traffic Summary versus Prior Year

2021 Volume Increase Over 2020: 25.18%

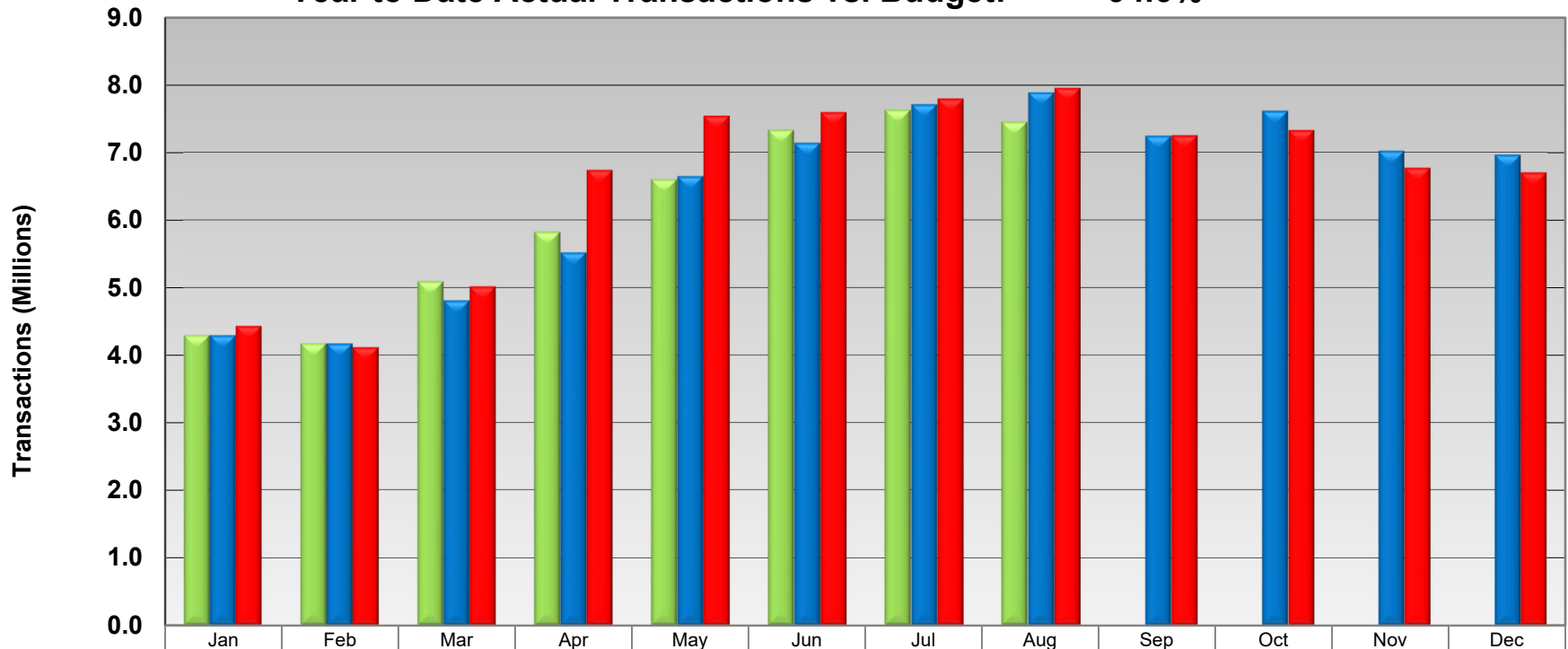

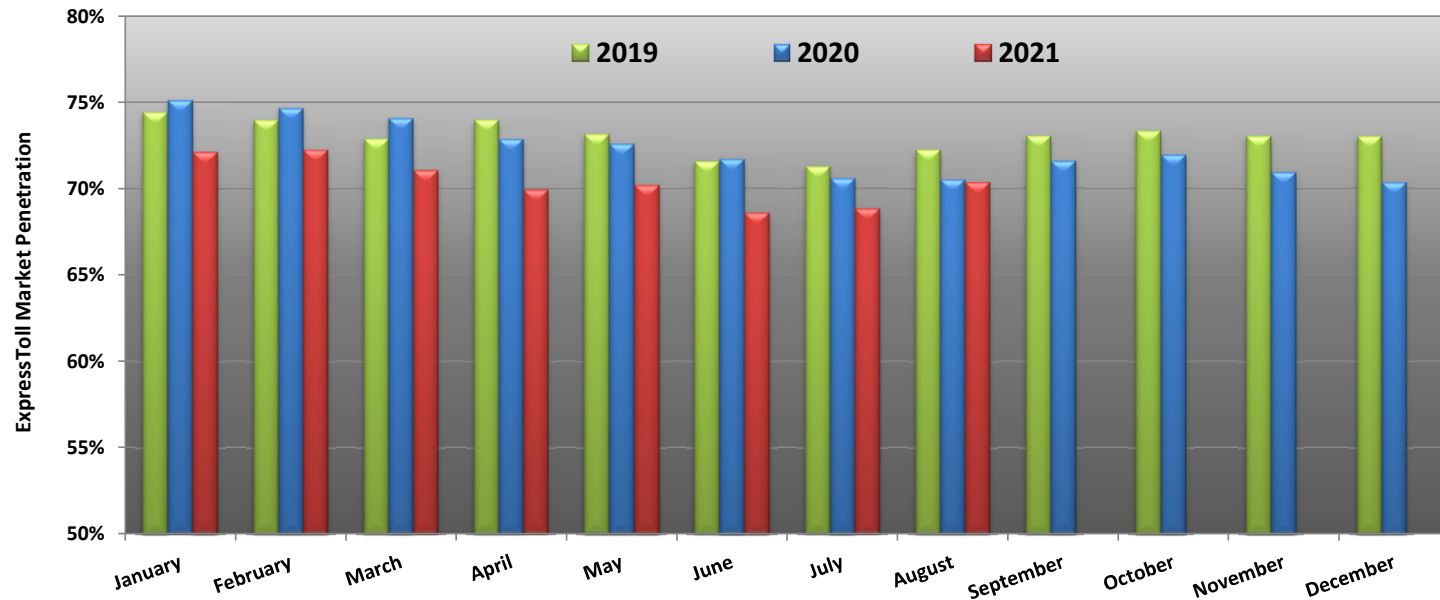
