MAKING HISTORY

For the first time in the E-470 Public Highway Authority's 30year history, E-470 customers saw a reduction in all mainline tolls along the 47-mile roadway starting on January 1, 2022. This

followed the decrease in rates at the mainline toll plaza just south of Pena Boulevard in 2018 and the multi-axle reduction in 2020.

In a stunning show of financial stability of the Authority and appreciation to customers, the E-470 Board of Directors approved a \$0.05 decrease at all mainline toll plazas, and a \$0.10 decrease at toll Plaza A at the southern end of the roadway in Douglas County for ExpressToll and License Plate Toll users.

EXCELLENCE IN TOLLING

The reduction in E-470

toll rates resulted in the International Bridge, Tunnel and Turnpike Association (IBTTA) presenting the Authority with a 2022 Toll Excellence Award in the Administration and Finance category.

E-470 was able to achieve this honor by updating its debt management policy and closing on a major debt restructuring in the spring of 2020. Despite the COVID-19 pandemic, which kept many people from commuting as they normally would, the restructuring allowed the Authority to move forward with its long-standing goals of:

- Restructuring and leveling its debt service profile .
- Achieving savings of \$80 million in 2020 with the 2020 • bond transaction
- Realizing savings of \$2 million in 2021 with a 2021 bond transaction
- Lowering toll rates for E-470 customers in 2022 .

The Authority and its Board of Directors were honored to be internationally recognized for financial resiliency that provided value and savings to customers during such a challenging time.







TRANSPORTATION SAFETY FOUNDATION

2022 was another record-breaking year for the E-470 Transportation Safety Foundation (TSF) – the Authority's charitable arm that raises money to support transportation safety initiatives throughout Colorado without utilizing toll revenue. After record proceeds were raised in 2021, the TSF awarded eleven \$2,500 grants, the most in its history, to local nonprofit organizations to fund transportation safety programs.

Additionally, the TSF was able to fund 23 Colorado high schools with \$200 each to support After Prom events, providing students with safe and fun activities on prom night.

The TSF also hosted its second ever Topgolf event in August. Thanks to the support of more than 40 organizations and nearly 200 participants, the 2022 event raised over \$60,000 to further support future foundation grants and program expenses.

BIKE TO WORK DAY

For the first time in the Authority's history, E-470 participated in Bike to Work Day on the E-470 Trail in Parker. Staff set up a breakfast station to educate dozens of people on bikes about E-470 trail projects and other multimodal enhancements along the corridor.

MARSHALL FIRE SUPPORT

E-470 is dedicated to supporting our partners in good times and in bad. Two days before the start of 2022, the historic Marshall Fire destroyed 1,000 homes in Boulder County. The Authority assisted the Northwest Parkway in initiating their Marshal Fire Toll Relief Program. E-470 provided back office support in reimbursing Northwest Parkway tolls for eligible ExpressToll customers who lost their homes in the fire.

PARKER ROAD PEDESTRIAN BRIDGE

Partnering to build out local trail systems continues to be a part of the Authority's commitment to supporting the communities surrounding E-470. Construction on the High Plains Trail connector project began in April 2022. When complete, the High Plains Trail will be connected to the Cherry Creek Regional Trail with a pedestrian overpass over Parker Road. The Authority partnered with Arapahoe County, Town of Parker, City of Aurora, City of Centennial and Douglas County to fund this \$5.2 million strategically significant trail project.

CHALLENGING YEAR WITH POSITIVE RESULTS

2022 brought several new challenges and traffic pattern changes along the corridor. The COVID-19 Omicron variant swept through the country and the local region causing travel disruptions over the holidays and into January. The trials and tribulations continued with a very snowy February, and gas prices and inflation on consumer goods spiked and remained historically high through the summer, causing variations in the Authority's normal summer traffic patterns and volumes.

Despite these challenges, the Authority successfully managed its operations, budget, capital projects, financial position, liquidity, and key financial metrics including debt service coverage. E-470 is self-funded and financed, and does not use any local, state, or federal funding. It is a financially stable roadway that is actively paying down its debts and expanding services to meet the continually growing demand of the communities it serves and improving regional transportation mobility.

Overall, the Authority ended the year 13% higher than 2021 traffic levels. Toll transactions finished at 96% of 2022 projections and budget. This correlated to net toll revenues ending at 97% of budget, with other revenues finishing the year over budget. This allowed the Authority to end the year at 99.7% of total budgeted revenues. This combined with finishing the year at 95% of operating expenses and debt service paid of \$98.2 million yielded a debt service coverage ratio of 2.11.

The Authority did not have any bond transactions in 2022, and remained steady with its ratings, maintaining the "A" underlying bond rating from S&P and "A2" rating from Moody's Investor Services. The Authority maintained compliance with its debt management plan, which includes financial goals for year-end results and achieving savings on debt transactions and structure, which will allow the Authority to continue to invest in future phases of expansion, technology, and infrastructure improvements.





ANNUAL CUSTOMER EXPERIENCE SURVEY

Each year, the E-470 Public Highway Authority asks customers to share their experience with E-470 and ExpressToll. Their answers help us identify ways to make the experience better for every customer, and also inform the Authority's future investments. More than 35,000 people responded to the 2022 survey, which covered customer demographics, communication channels, payment methods, road conditions and satisfaction with E-470 and ExpressToll. BUILDING MORE CAPACITY

In September of 2022, the Authority started construction on the latest phase of the E-470 Road Widening and Trail Expansion program. The Authority is adding more capacity in a rapidly growing part of the Denver Metro area by adding a third travel lane in each direction of E-470 from I-70 to 104th Avenue, a distance of 11 miles.

The project also includes several interchange improvements. Crews will construct two new interchanges at 48th and 38th Avenues to improve connectivity and traffic flow in newly developed communities, like the Aurora Highlands, High Point, and the Windler Homestead. They will also expand the Pena Boulevard and 64th Ave. interchanges and widen the existing bridges.

BUILDING OUT LOCAL TRAIL SYSTEMS

As part of the road widening project, crews will also construct extensions of the High Plains Trail, a 10-foot-wide concrete paved multi-use path, four miles from 26th to 64th Avenues in the City of Aurora and two miles from 88th Avenue to 104th Avenue in Commerce City. This is in addition to the already completed 12.5 miles of trail along the corridor. The Authority is also partnering with the City of Aurora to build a connection from the High Plains Trail to Jewell Avenue, and with Adams County to build part of the future High Plains Trail as part of the County's Riverdale Bluffs Regional Park project.

NEXT GENERATION TOLLING SYSTEM

E-470 kicked off its Next Generation Lane Toll System planning and design during the summer of 2020. The Authority is currently testing and integrating the next generation system along the roadway, completing its first successful transition during fall of 2022. This new technology allows for improvements in accuracy, reliability, and efficiency for both customers and the Authority. The new system is anticipated to be fully operational near the end of 2023.

NEW SYSTEM IMPROVES MOUNTAIN TRAVEL

E-470 also supported its partners at the Colorado Department of Transportation and its tolling arm Colorado Transportation Investment Office (CTIO), in the golive of the I-70 Mountain Express Lanes. The next generation lane toll system was installed and integrated at this new location as well. Tolling began on the Westbound Mountain Express Lanes in early July of 2022. The 12-mile managed lane stretches from the Veteran's Memorial Tunnel to Empire.



SAFETY IS KEY

E-470 continues to make safety a top priority by investing in enhancements on and off the roadway. In 2022, the Authority made the following improvements to continue providing a safer commute for its customers:



IMPROVED INTERSECTION SAFETY

The Authority partnered with the City of Thornton to install traffic signals at the intersection of E-470 and Quebec Street to facilitate safer crossings for those in vehicles and on foot. The Authority is also partnering with the City of Aurora to fund future temporary traffic signals at the Jewell Avenue and Gartrell Road interchanges.

ENHANCED VISIBILITY AT RAMPS

Crews refreshed pavement markings on several E-470 ramps to make them easier to see at night and in inclement weather.



UPGRADED SIGNAGE

The Authority installed two new types of signage along the roadway in 2022 to catch the attention of drivers. First, crews installed solar powered back-lit "do not enter" signs at ramps and crossovers to alert potential wrong-way drivers. Second, the chevron directional signs at the off ramp from northbound E-470 to Gun Club Road/Quincy Ave were upgraded with solar powered flashing lights. The new feature will help safely guide drivers through the curve from dusk until dawn.







NEW VEHICLES TO ASSIST MOTORISTS

NEW CABLE BARRIER LOCATIONS

E-470 utilizes cable barrier in the median along all 47

miles of the roadway to reduce cross-over crashes. In 2022, the Authority began installing this safety feature

at select ramp locations identified for improved safety.

If a vehicle veers off the roadway, the cable barrier will

absorb its impact energy to reduce the severity of a crash.

Work was complete on the ramps from northbound E-470

to I-76 in Commerce City and from northbound E-470 to northbound I-25 in Thornton with additional locations

scheduled for cable barrier installation in 2023.

The E-470 Roadside Assistance team provides free, 24/7 help to motorists along the roadway, and in 2022, their vehicles got a major upgrade. The team will be able to better serve customers after transitioning to larger, Ford F-150 trucks with enhanced features including:

- Front push bumpers to clear disabled vehicles from the roadway faster
- Kinetic tow ropes to assist stranded or stuck motorists
- Slide out beds for safer access to tools
- Portable air compressors for quicker assistance
- High-vis, retroreflective graphics, and additional strobe lights for better visibility at night

The Roadside Assistance teams also became even easier for customers to reach in 2022. Any customer with a mobile phone can now dial *470 to be connected directly to roadside assistance dispatch for help along E-470 anytime.

PRIORITIZING SUSTAINABILITY

E-470 is committed to environmental stewardship, especially in the communities surrounding the roadway. Some highlights of 2022 sustainability efforts include:

PROTECTING WATER QUALITY

The Cherry Creek and Barr Milton Watersheds are adjacent to E-470, and the Authority plays a role in keeping those watersheds clean through a permit with the Colorado Department of Public Health and Environment. In 2022, E-470 worked to educate customers on the ways they can do their part to help protect and improve water quality. The Authority communicated these tips to customers through its website, quarterly newsletter, and social media posts.

IMPROVING AIR QUALITY

The Authority partners with the Regional Air Quality Council to promote the Simple Steps. Better Air. program. On poor air quality days, the Authority shares ozone alert messages on variable message signs along E-470 to remind drivers of the actions they can take to reduce vehicle pollution, such as avoiding engine idling.



EV CHARGER UPGRADE

Over the summer, the Authority upgraded the ChargePoint "DC Fast Charge" electric vehicle (EV) charging units at its administrative building in Aurora. The new units increase output based on what an EV will allow, and feature modular technology, which allows for future upgrades without needing to fully replace the units. The Authority offers this service to the public free of charge.
