Call to Order:

Councilmember Diak, noting the presence of a quorum of the directors, called the regular meeting to order at 9:00 A.M.

Pledge of Allegiance:

Councilmember Diak led all present in the Pledge of Allegiance.

Public Comment:

None.

Consent Calendar:

Councilmember Pawlowski moved approval of the consent agenda, comprising meeting minutes of June 13, 2024 and 48th Avenue Maintenance IGA. The motion was seconded by Councilmember Bergan and approved unanimously by the Board.

Mr. Doctoroff addressed the Board of Directors and introduced Sergeant Bryce Schumann to recognize Albert Jacquez of the WSP Roadside Assistance crew for his work on February 23-24, 2024. Mr. Jacquez stopped and redirected an intoxicated wrong way driver and in so doing, prevented fatalities or serious injuries while the Colorado State Patrol was contacted and subsequently arrested the suspect. Sergeant Schumann noted Mr. Jacquez's selfless action in favor of public safety and presented him with a Recognition of Outstanding Service Award. The Board of Directors and all present commended Mr. Jacquez.

Sergeant Schumann then presented the Colorado State Patrol's annual statistics for 2023, including noting that distracted driving is a major problem coincident with the use of cell phones while driving. Councilmember Pawlowski noted her observations about higher speeds of vehicles and driving over the posted speed limits. Sergeant Schumann responded accordingly noting speed is an issue. Councilmember Douglas thanked Mr. Jacquez again for his bravery. He then commented on speeding in construction zones. Commissioner Tedesco commended the Colorado State Patrol for their work and thanked Mr. Jacquez for his efforts to make E-470 safe. Councilmember Diak commented on wrong way drivers.

Risk Management Annual Crash Report Briefing: Mr. Doctoroff reviewed the risk management annual crash statistics for 2023, along with property damage collections with the Board of Directors. He noted collecting on property damage and responding to incidents was a cross departmental effort. He reported on the use of a Third Party Claims Administrator and the increased financial amounts recovered after repairs resulting from accidents. He reviewed crashes by year and location, trends, deer collisions, wrong way drivers, and accident site clearance.

Public Affairs Department: Mid-Year Update:

Ms. Carson addressed the Board and provided a mid-year 2024 update on various Public Affairs Department efforts and activities. She played the latest E-470 Now Video and then reported on media relations matters, current advertising campaigns, the top promotional tactics, quarterly newsletters, and email communications. Ms. Carson then reported on the positive results of the negative balance email campaign as well as the new and closed account email program. She then provided a report on social media by platform and reported on member jurisdictional support. Finally, she reported on the E-470 Mascot and the contest to name the E-470 Road Runner. Councilmember Bergan noted Global Fest being put on by the City of Aurora. Councilmember Douglas inquired about new car registrations and Authority advertising and Ms. Carson responded. Commissioner Tedesco expressed appreciation for the outreach and noted most negative feedback he receives relate to non-E-470 roads for which the Authority does the back office. He inquired about trying to explain the same to the public. Ms. Darlington noted CTIO would be happy to help with educational efforts and noting the safety benefits. She then stated that additional educational efforts are underway with respect to how to use the CDOT/CTIO lanes.

Executive Director Report:

Ms. Vescera introduced Steve Bedard as the Operations Department's new Risk and Safety Specialist. Mr. Taylor then introduced Scott Jackson as the Authority's System Administrator for the Information Technology Department. Mr. Thomson introduced Josephine Foote as the Engineering Department's Summer Intern. Finally, Mr. Donahue reported on several new Finance Department positions as well as the Finance Director search.

Mr. Donahue reported on the culmination of partnering with area developers, member jurisdictions for the 38th Avenue Interchange which he reported is now open.

He reminded the Board of the upcoming Annual IBTTA Conference in Cleveland, Ohio October 26 – 29th. He then noted for the Board that the Central Maintenance Facility Ribbon Cutting Ceremony will be held following the Board's meeting on August 8, 2024 at 11:00 a.m.

Mr. Donahue reported on the official notice from Plenary Roads Denver triggering a wind down period under the 3-Party Tolling Services Agreement Plenary and High Performance Transportation Enterprise, d/b/a/ CTIO.

Mr. Thomson then reported on the June 21, 2024 incident stemming from a tractor-trailer that hit an overhead sign and closed two southbound lanes of E-470 and necessitated the use of a crane to remove the damaged sign. He noted temporary signage will be installed until a new sign can be installed. He noted the long lead time for delivery of a replacement sign structure. Mr. Thomson thanked the Authority's staff for their hard work clearing and remediating the incident.
